MEMBERSHIP

ELIGIBILITY



- Members of the European Fellowship must be in accordance with the aims and objectives of the constitution.
- MEMBER IN TOUCH category only available for membership of a maximum 3 year term, and have the intention to become full or associate members.
- ASSOCIATE MEMBER category is only open to organisations with a membership not exceeding 5000 members.
- FULL MEMBER category is open to **ALL** members of European Fellowship.
- International Umbrella Organisations can become an a indefinite MEMBER IN TOUCH and would work in partnership with European Fellowship.

MEMBER IN TOUCH



Benefits

- Limited places available on selected EF Activities & Events.
- Limited financial assistance available to participants taking part in EF Activities and events (subject to eligibility).
- Limited assistance at local events.
- Invitation to contribute to the Annual General Meeting, but no voting right.
- Chairmanship guidance and support available.
- International Umbrella Organisations *separate guidelines apply.

FEE : No charge

ASSOCIATE MEMBER



Benefits

- Places available on selected EF Activities & Events.
- Financial assistance available to participants taking part in EF Activities and events (subject to eligibility)..
- Assistance at local events.
- Invitation to contribute to the Annual General Meeting, but no voting right.
- Chairmanship guidance and support available.
- Ability to Host EF Activities and Events.
- Associate members can apply for positions on Chairmanship excluding Chair position.

FEE : 300€ per year

FULL MEMBER



Benefits

- Places available on all EF Activities & Events.
- Financial assistance available to participants taking part in EF Activities and events (subject to eligibility).
- Assistance at local events.
- Invitation to contribute to the Annual General Meeting, and voting rights.
- Chairmanship guidance and support available.
- Ability to Host EF Activities and Events.
- Full members can apply for all positions on Chairmanship.

**FEE : 300€ per year

PARTNERSHIP

SUPPORTED *by*



- After activity/event has been approved for partnership by the Chairmanship of European Fellowship, promotion of activity/event through all our communication outlets.
- Joint working on promotional material, including media resources.

PARTNERED *with*



- After approval, and as well as promotion, and joint working on publicity, use of the EF Assistance Service to be made available if requested.
- Opportunity of using European Fellowship organisational Trainers at the event
*reimbursement of all additional costs incurred by volunteers.

CREATED*for*



- All events that are run, funded by (including using external funding bodies) and coordinated by European Fellowship.
- These events will be publicised jointly with members, and if applicable will make use of the Assistance Service.

ASSISTANCE

ASSISTANCE SERVICE



European Fellowship Assistance Service provides support to international participants attending locally run events in member organisations.

We will provide training, resources and materials to help organisations support international participants.

Organisations will provide volunteers and overall management of the service at the event.

The Assistance Service is a voluntary scheme, and is not a requirement for an Event, or needs to be used by member organisations if provided by host.

ASSISTANCE SERVICE



Requirements.

- An event that has a minimum 100 expected participants locally.
- A local contact who will co-ordinate the Assistance Service at the event.
- English language programme material available for international participants.
- Suitable accommodation for international participants.
- A suitable ratio of local trained volunteers to supervise, support and communicate with international participants.
- Suitable transport provision for international participants, directly or through guidance materials and support.

ASSISTANCE SERVICE



Partnership.

- Joint working between organisational contact for the event and the Chairmanship to promote the event and source participants from EF organisations.
- Training organised by European Fellowship and provided to host organisation to be able to facilitate the Assistance Service. Training to be facilitated by most appropriate method, as determined by the Chairmanship.
- Open dialogue before, during and after event to make sure the Assistance Service runs effectively.
